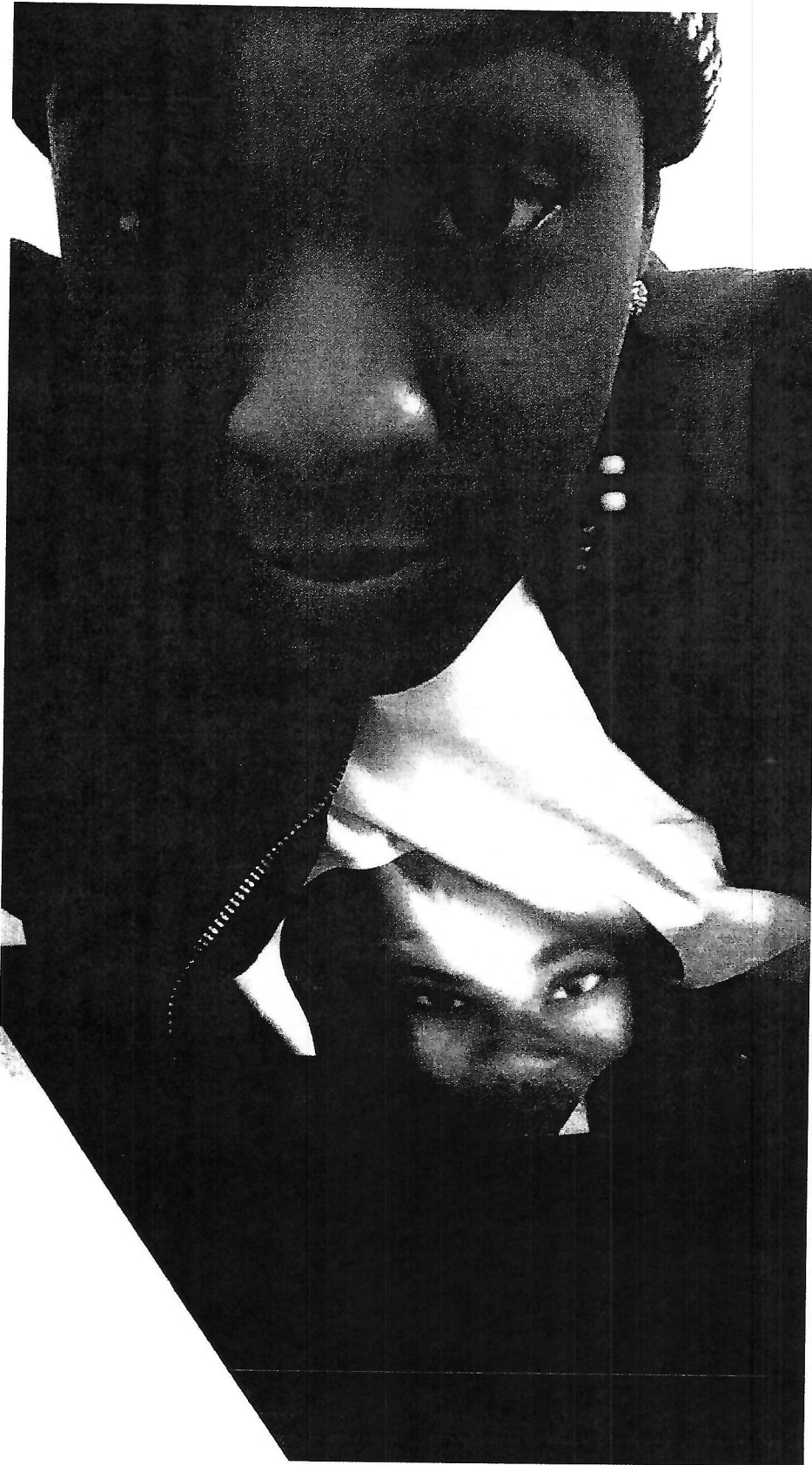



WAIVER OF CONSTITUTIONAL RIGHTS, AGREEMENT TO STIPULATE, AND JUDICIAL CONFESSION

In open court and prior to entering my plea, I waive the right of trial by jury. I also waive the appearance, confrontation, and cross-examination of witnesses, and my right against self-incrimination. The charges against me allege that in Harris County, Texas, **BROOKS, ALESHA MONAE**, hereafter styled the Defendant, heretofore on or about SEPTEMBER 12, 2023, did then and there unlawfully, intentionally and knowingly engage in conduct that placed D.B., a child younger than fifteen years of age and hereafter called the Complainant, in imminent danger of bodily injury, namely, by leaving the Complainant, a two year old child, in a feces covered apartment alone and unsupervised with access to a hammer, and the Defendant did not voluntarily deliver the Complainant to a designated emergency infant care provider under Section 262.302 Texas Family Code.

AGAINST THE PEACE AND DIGNITY OF THE STATE.


I understand the above allegations and I confess that they are true and that the acts alleged above were committed on SEPTEMBER 12, 2023.

In open court I consent to the oral and written stipulation of evidence in this case and to the introduction of affidavits, written statements, of witnesses, and other documentary evidence. I am satisfied that the attorney representing me today in court has properly represented me and I have fully discussed this case with him. I waive any further time to prepare for trial to which I or my attorney may be entitled.

The Plea Agreement:

I intend to enter a plea of guilty, agree to the state's plea bargain offer, and agree to the following recommendation:

2 YEAR DEFERRED ADJUDICATION, TRAS, EFFECTIVE DECISION MAKING CLASS, PARENTING CLASS.
